The special meeting of September 20, 2021 was called to order by Chair Castro at 5:04 pm.

DISCUSSION AND POSSIBLE APPROVAL OF COVID VACCINE INCENTIVE

Board members received a staff report from Director Jones in their Board packets prior to the meeting.

Director Jones stated that the District's health insurance provider, SelectHealth, has instituted a cash incentive for employees that are not yet fully vaccinated, but would become fully vaccinated by December 31st. Director Jones explained that in response to this incentive program, Summit County has also implemented their own Vaccine Incentive for employees and spouses that have already received the vaccine. Director Jones stated that the District is following Summit County as it relates to COVID protocols and mandates for all District facilities and explained that in order to stay consistent with this practice, the District would like to also mirror Summit County in their Vaccination Incentive Program.

Director Jones stated that the District anticipates the cost could be up to \$21,000 out of the 2021 operating budget, explaining that the program would be available through December 31, 2021. Due to a large reserve in the self-insurance plan the District will take a premium holiday for the months of November and December 2021. The monthly insurance premium amount is

months of November and December 2021. The monthly insurance premium amount is approximately \$30,000 per month and will be used to fund the District's Vaccination Incentive

- 34 Director Jones explained that this program would be advertised by email to all eligible staff 35 members and participation would be on a voluntary basis. Director Jones stated that, in order to
- 36 participate, employees must show a copy of their and/or their spouse or domestic partner, if
- applicable, vaccination card to District Administrator, Stacy Carpenter at the Trailside office. 37
- 38 Director Jones stated that the District will not make or retain copies of the employees'
- 39 documents. Director Jones explained that payment would be received via the employee's next 40 paycheck.

Brown and Director Jones discussed how the District came up with the approximate cost of \$21,000. Moffitt and Director Jones discussed SelectHealth will cover the incentive costs for full-time employees who are not yet fully vaccinated, and that all other employee incentives would be funded by the District.
